CarbonWA

According to James Hansen, the former renowned NASA climate scientist, a carbon tax is an essential tool in helping limit climate change! CarbonWA is seeking to get a revenue-neutral carbon tax – modeled on British Columbia's successful tax swap – in Washington State. This plan will tax pollution, not jobs, by placing a \$25 charge per metric ton of fossil fuels consumed, generating about \$1.7 billion per year. It will cut the sales tax by 1%, virtually eliminate B&O taxes for manufacturers, and rebate \$200 million to working families.

We will need 300,000 signatures before the end of the year in order to get this measure on the ballot in 2016. Our campaign will likely start in April.

Talk With a Climate Scientist

Still want to debate the scientific evidence, or become more confident to talk to climate change deniers? Come to this table and discuss what scientists know about climate change and why it truly is the looming crisis of this century.

Speaker: Dr. Robert Bindschadler whose career spanned over 30 years at NASA where he retired in 2010 as the Chief Scientist of NASA's Hydrospheric and Biospheric Sciences Laboratory and a Senior Fellow of the Goddard Space Flight Center. He has led major multi-institutional and international research projects, most recently a major ice-sheet modeling study for the IPCC. His extensive field experience includes leading 18 Antarctic field expeditions to study dynamics of the West Antarctic ice sheet. He has testified before Congress, briefed the U.S. Vice President, published over 150 scientific papers, including numerous review articles and is often quoted commenting on glaciological impacts of the climate on the world's ice sheets and glaciers.
