

Jefferson County Local Food System Council Statement of Interest

Thank you for your interest in participating on the Jefferson County Local Food System Council. The mission statement of the Food Council is to create, expand, and strengthen a local food system that is accessible, healthy, sustainable, and economically vibrant.

The Food Council is a collaboration of representatives from a broad spectrum of our local food system, potentially including, but not limited to, the arenas of: health, nutrition, education, food security, resources, conservation, agriculture, manufacturing of value added products, distribution, food retail sales, restaurant or institutional food preparation, elected or government agency officials, food or resource waste management, and/or engaged community members.

Jefferson County has tremendous potential for strengthening a more secure, accessible, and locally-sourced food system. Our Food Council has been inspired by other Local Food Councils thriving around the United States. While our Food Council does enjoy strong rapport with local government bodies (the City, the County, the Port, the Health Dept) it functions as an independent body in terms of decision making and local food system recommendations. There is a strong emphasis, however, on positive collaboration.

This group of 15 to 20 individuals meets monthly to identify gaps and weaknesses in our local food system and find and/or develop resources to address them. Food Council meetings take place on the 4th Thursday of January through June, from 5:30 - 7:30 PM, takes July and August off, and meets on the 1st Thursdays from September through December.

Regular attendance on this active board is required if you are interested in serving. The Food Council does form committees as needed. Committee membership is strongly encouraged, but voluntary.
